What is Positive Discipline in Everyday Parenting (PDEP)?

Positive Discipline in Everyday Parenting (PDEP) is a Canadian program for parents and caregivers of children from birth to adolescence. The program is delivered in-person to groups of parents/caregivers by Program Facilitators who have been trained, mentored, and certified. Program Facilitators are community-based service providers who deliver PDEP on a not-for-profit basis.

What is the Updated Version of PDEP?

The PDEP parent program and facilitator training have been revised to integrate a trauma-and-violence-informed perspective, an emphasis on parental self-regulation, and new content on the development of gender identity and sexual orientation. The updated version is delivered over 9 weekly 2-hour sessions. The program must be delivered by two Co-facilitators, both of whom have been trained in the updated version of PDEP.

What are the Requirements to Become a Certified Facilitator in the Updated Version of PDEP?

The certification process is, like all of PDEP, built upon a scaffold of practice and support. Prior to becoming certified, Facilitators will:

- Participate in a 5-day Facilitator Training in the updated version of PDEP.
- Successfully co-deliver the program within 6 months of the Facilitator Training.
- Participate in 3 online mentorship sessions with a Trainer – before, during, and after they deliver their first program – and share weekly self-reflections with their Trainer.
- Demonstrate solid knowledge of the program content, skill in its delivery, and a commitment to maintaining program quality and integrity.
